Insurance Open Enrollment

Risk Management has scheduled open enrollment meetings for retirees from 9 a.m. to 3 p.m. on August 11 and August 12 in the Estancia High School Commons. Representatives from all of the insurance vendors serving the district will be available to meet one on one with retirees to explain the advantages of their programs and to answer your questions. Risk Management plans to send out open enrollment packets via U. S. Mail during the last week of July. If you have not received your packet in the mail by August 3, you should call Risk Management.

Like so much of life, there is some good news and there is some bad news relative to district-offered insurance plans. Let's take a look at the good news prior to tackling the bad news. Both of the CIGNA dental plans, HMO and PPO, have seen a very slight reduction in premiums. This small discount was probably due to CIGNA winning the health insurance contract from the District. Both of the SCAN Medicare Advantage Plans, Basic and Enhanced, will experience no rate change over the premiums charged last year. This will be the second consecutive year of experiencing a rate pass from SCAN. In addition to SCAN, the District will offer Kaiser Senior Advantage as another Medicare Advantage HMO for retirees.

CIGNA will be replacing Anthem offering a PPO with coordination of benefits with Medicare. I have been assured that the CIGNA PPO program has a 95% match with current health care providers. You can check online with CIGNA, OAP Expand Program, to see if your current providers are a part of the CIGNA PPO network, or check with the CIGNA rep at the open enrollment meetings. Simply comparing the two PPO programs, Anthem PPO and CIGNA PPO, PPO to PPO, it would appear that the CIGNA plan offers a higher quality product with no deductibles and reduced out-of-pocket co-pays. Current district employees will be offered a choice between CIGNA PPO or CIGNA HMO during open enrollment but the CIGNA HMO will not be available to retirees, since they have the two SCAN HMO Medicare Advantage Plans and the Kaiser option.

Now, the bad news! The CIGNA PPO plan premium will require a 30% increase over the current year's POS Plan. Sandy Asper and I have met with Russell Lee-Sung, Associate Superintendent, to express our profound concerns about this tremendous rate increase and the financial burden that it will bring to our fellow retirees. We recognize that there are cheaper alternatives offered with the HMO's, but we also recognize that an HMO may not be suitable for some people. Therefore, we requested that the District modify current district policy that discourages retirees from "shopping" for health insurance by forever banning them from participating in district-sponsored insurance

programs if they ever refuse to participate in a district-sponsored insurance plan. In the light of this historically high rate, we posed the question of why not offer them a "trial period" where they could go outside of district plans to find something cheaper. The trial period might have some limits, probably somewhere between one and three years. I have the name of a broker who has been able to provide comparable insurance products for several highly respected N-MUSD certificated retirees. These products reduced their health insurance premiums at substantial savings over the cost of continuing district-sponsored health insurance. The severe penalty of "no return....ever" is so severe that it can be considered as almost inhumane relative to a 30% increase in premium. State law, as embodied in AB 528, clearly has language that would permit this modification of District policy.

On Friday, July 24, I presented my case for the concept of a "trial period" to the trustees and District administration during public comments at a special board study session. After the meeting, in a private conversation with District Superintendent, Dr. Fred Navarro, he indicated that he would be open to working with Kimberly Claytor, President of N-MFT, on an MOU, Memorandum of Understanding, embodying the concept of a "trial period" into contract language. A few minutes later, I shared the Superintendent's comment with Kimberly and Nicholas Dix, N-MFT Chief Negotiator. They indicated their willingness to call Dr. Navarro to meet and discuss working on developing an MOU permitting the "trial period." All parties are well aware of the importance of time element with the fast approaching open enrollment period.

A few words of caution are in order. First off, current board policy does not permit a "trial period," and the "no return" policy has been vigorously enforced. In my many years of working as an Assistant Chief Negotiator for N-MFT, as well as serving on many negotiating teams through the years, I have been involved in numerous attempts to develop and implement MOU's. Contract language must be precise so that no misunderstandings are apt to occur. We all are aware of the tyranny of the English language with so many words having multiple meanings. I have, personally, been a part of situations where all parties were in general agreement on the concept, but simply were not able to agree upon the language necessary to convey that concept with all of the possible limitations and ramifications using precise legal language. This is where I have great empathy for the work of our lawmakers and understand how our judicial branch has the ultimate word on the interpretation of the law.

While we are most pleased that the District Administration and the N-MFT leadership are willing to work on allowing a "trial period," we should not count on it being a reality prior to August 11. First they must actually produce a signed MOU that will permit the "trial period" in contract language approved by the Board. In the meantime, I can only suggest that we think positive thoughts and if you are religious, please join me in praying for divine guidance and help for Dr. Navarro, Kimberly and all their assistants as they tackle this most important project, on behalf of all N-MUSD retirees trying to cope with rising health care costs. *Dave*

Community Outreach



As summer is upon us, the board meeting will be once a month until September and I hope that nothing of importance to the employees is introduced during these quiet times.

On the Donate Life Run / Walk

The Gift of Life

On March 28th of this year my wife, Linda and I celebrated the tenth anniversary of my donation of a kidney to her. It is hard to believe that a decade has passed since that eventful day in our lives. One activity that we have been involved in since my retirement in 2008 has been with the Donate Life organization and attending a transplant support group, <u>A Gift of Heart</u>. This group is made up of people who have received a transplant: be it heart, kidney, liver or lung; people waiting for a transplant, living donors (like myself) and care givers.

We meet on the fourth Monday of every month alternating between St. Joseph in Orange and

Mission Medical Center in Mission Viejo. At those meetings we share experiences, provide support for one another and occasionally have guest speaker. The leader of this group, Gary Foxen, who received a single lung transplant over 15 years ago, was the individual who came up with the idea of a Donate Life float in the Pasadena Rose Parade. For the past 13 years a Donate Life float, with the flora graphic images of individuals who had died and their organs were donated to people waiting for transplants, has rolled down Colorado Boulevard. Riding on the float are transplant patients, living donors and families of deceased donors. Unfortunately, Gary died in November of an aggressive cancer of his intestinal tract.

On the fourth Saturday of April, the Donate Life organization sponsors a 1K-5K Run/Walk at Cal State Fullerton to raise money for One Legacy, the non-profit organ and tissue recovery organization serving the seven-county greater Los Angeles area. This event was the inspiration of Craig and Kathleen Hostert. In 1998, Craig received a kidney from his wife, Kathleen, but 14 years later it failed, so he then received another kidney, this time from his son, Justin. Linda and I have

A Trip of a Lifetime

What do onion domes, twenty-hour sun filled days and Matryoshka have in common? All were part of my experience on a trip to Helsinki, Finland and eastern Russia.

Helsinki was a delight. It was fun to mix with the locals in the outdoor market, the plazas and train station. A soft reindeer wallet is a prized souvenir. We learned May 28th is national high school graduation day. We saw graduates celebrating on the town: in bars, restaurants and dancing on crowded buses. We utilized the "Hop On, Hop Off" bus, an inexpensive way to see the major sights of the city. I borrowed a bicycle from the hotel. Having gone a short distance, I stopped. The bike fell as did I. Later I believed I had broken 2 toes, but they weren't going to stop me.

Three days later, we boarded a bullet train to Saint Petersburg. The train was oh-so-smooth, even with speeds of 218 k/h (@135.4 mph). When passport inspectors entered, conversations dropped considerably and regained their volume once they exited. Old habits of intimidation die hard.

Saint Petersburg is a vibrant, architecturally gorgeous city. The amount of gold used as decoration is jaw-dropping. The delicately jeweled Faberge eggs commissioned by czars for their wives and mothers are stunning. I became accustomed to sunsets close to 11 pm and rising around 2 am.

As we cruised towards Moscow, we would stop in a city with artistic, historical, geographical or religious significance. Our first stop was in Mandrogy, a quaint village with cobbled streets. Here we were able to see the nesting Matryoshka Dolls being made by artisans in their shops. Our ship entered a series of locks needed to adjust to the varying elevations

At Kizhi we visited a wooden church, built completely without a single nail, being restored. Other highlights included a chance to visit a local school, & the Kirillo monastery. Yaroslavl, according to legend, was founded on the very spot where Prince Yaroslavl killed a bear. In Uglich, we visited a Russian home. The hostess invited us to sit down at a long table. We were treated to homemade pickles, moonshine, and pastries. Because the government controls the making of vodka, citizens usually make their own. Aboard ship, we also had a chance to taste a variety of vodkas, some of them 40 proof. I learned very quickly Russian vodka is STRONG.

year. A Gift of Heart support group decided to form a team in memory of Gary Foxen, so on Saturday, April 25th we were there walking in his memory.

For many who have reached our "seasoned citizen" status don't think that we are eligible to be considered as a living donor. Living donors need to be between the ages of 18 and early 70s and can include parents, children, siblings, other relatives, and friends. An ideal donor should have a genuine interest in donating and a compatible blood type with the recipient. Donors should be in good

general health. Donors do not need to be genetically related. Typically, someone who has cancer, diabetes, kidney disease, heart disease, liver disease, sickle cell disease, HIV or hepatitis will not qualify to be a donor. Many "seasoned citizens" think they would be too old to consider organ/tissue donation at the time of their death, but you would be surprised that there is no strict limit of age for organ donation. In general, organs may be donated by someone as young as a newborn or as old as 75. As for tissue donation, the age limit for such is below 80 in the case of corneas and between 16 and 60 in the case of long bones. There is no age limit for skin donation.

If you have not done so already, I would urge you to consider registering as an organ/tissue donor through the California Department of Motor Vehicle website: www.dmv.org/ca-california/organ-donor.php or through the Donate Life website: www.donatelife.net/organ-donation/ and get that pink dot on your driver's license and celebrate "The Gift of Life.".
