Insurance Update by Dave Brees, V.C. Health and Benefits



We have concluded the first quarter of the 2015-16 school year under the CIGNA PPO contract, but at the time of this writing, no utilization reports have been shared by CIGNA. Until utilization reports have been issued, it is impossible to speculate on renewal premium rates for the next school year. The Risk Management Office has issued a report to the Benefits Committee relative to the census and migration within the various health

insurance programs offered by N-MUSD. The most recent census report appears to lend credence to my concern about the role of adverse selection on the future viability of the PPO program. I witnessed the death spiral of our District self-insured health insurance program created by adverse selection. Obviously, the CIGNA PPO pool could be much larger overall, so my concerns may be unjustified. I plan to get more information on the pooling arrangement with CIGNA and share that information in a later report. I suppose that I just have to learn to accept it as just another inconvenience of being excluded from membership on the N-MUSD Benefits Committee.

Since the negotiations process for the 2016-17 school year will be underway shortly, I plan to propose that the District conduct a survey of those retirees who qualified for the One Time, Opt Out provision of the current contract in order to capture data that might be useful in providing direction to all parties concerned with retiree health insurance. I fully realize that retirees who found alternatives to District-offered health insurance have only had about four months of experience with the new plan, but I believe that we need a preliminary examination of consumer satisfaction, even at this early date rather than waiting for the results during open enrollment in August. My original proposal for the Opt Out provision that I made to the Board in July of 2015 was for a trial period of one to three years. I understand the additional load of record-keeping required of the Risk Management Office that an Opt out provision requires, but a retiree making such a life-changing decision (that could forever impact his/her future) might merit more than a one year or less trial period.

At the November meeting Mayor Messinger and staff (Costa Mesa) presented a check for \$20,000 to the district for arts at Estancia and Costa Mesa High Schools. The costs for the damage that occurred to three Newport-Mesa schools during the surprise rains in September will be paid for by the contractor.

The board saw a conceptual drawing of CdM's library renovations which will create spaces for the students geared to 21st Century learning. \$400.000 has been donated by the CdM Library Foundation toward this project. 50 Nearpod licenses have been purchased for Newport Elementary to facilitate one-on-one technology using Kromebooks. These licenses will allow users to create lesson plans across the district.



Fall and Winter 2015-2016 has been a busy time for the N-MFT Retired Chapter. In November we helped organize the Veterans and Labor Day Celebration at the Orange County Fairgrounds. It was estimated that there were over 9,000 attendees in the event's third year, quite an increase over the previous two years. Besides contributing \$500 to help underwrite the event, we also had many of our members participate in helping kids create thank-you cards for veterans. Our station was the busiest of the event with the exception of the one where a crowd was listening and dancing to the



music of the '40s and 50's. My granddaughter helped with the face painting activity, and my daughter and I had the honor of writing the names of several hundred Vietnam veterans on individual Appreciation Certificates at the end of the event. A great time was had by all.

In December we combined our efforts with the Fairview Community Church members in making a memorable Christmas experience for five local families (twenty-two individuals) through the Share Our Selves' Adopt-a-Family program. We provided each family member with wrapped presents and gift cards to Target and local grocery stores. Our monetary contribution to this endeavor was \$500. The church leadership was very appreciative of our assistance in this charitable holiday activity, and we got a lot of personal satisfacton from participating.

Several of our members helped evaluate the Teacher of the Year applications in early January at the N-MFT office. This assistance was much appreciated by Blanca Salas, the N-MFT staff person in charge of organizing this event. We also had some of our members on the selection committee, observing the finalists in their classrooms and interviewing them afterwards. The Elementary Teacher of the Year selected was Melissa Price, a special education teacher at Adams Elementary. The Secondary Teacher of the Year selected was Tim McFadden, a music teacher at TeWinkle Middle School. These are two fine teachers who will go on to represent our district in the Orange County competition.

Some of our members also helped evaluate applications submitted to Newport Mesa Schools Foundation's Grants to Teachers. Besides several individual contributions by some of our members, the N-MFT Retired also contributes \$1,000 to this worthwhile organization in the memory of past president, Phyllis Pipes. Several of us are looking forward to attending the ceremony for both the Grants to Teachers and Teachers of the Year on February 11. This has been a very active time of year for our chapter's community outreach.


